

Report on Site Visit of Shri Jai Shankar, Managing Director, NETC at Assam & Meghalaya (from 15.10.2025 to 16.10.2025).

1. CSR MoU exchanged with the District Commissioner, Kamrup District, Assam on dated 15.10.2025:

Shri Jai Shankar, Managing Director of NETC, has exchanged a Memorandum of Understanding (MoU) with Shri Deba Kumar Mishra, District Commissioner, Kamrup, Assam on dated 15.10.2025. The MoU outlines funding for the “Infrastructure Development of Chaygaon Natya Mandir, Chaygaon, Kamrup, Assam,” as part of NETC's Corporate Social Responsibility (CSR) initiatives.
